In return for you granting me such permission, I hereby agree to the following legally binding terms and conditions:

1. Any and all photographs, videotape footage and/or film footage (the "Materials") may be used solely for publication in _____, and for no other commercial or non-commercial purposes whatsoever.

2. I agree to shoot only as directed by a member of your staff and at no other time inside the venue. I agree to comply with all requests made or directions given by your representative and to cooperate fully so as not to interfere with your concert or other activities.

3. I acknowledge and agree that the privacy of Paula Abdul ("Artist") is highly valued and that all efforts are made to maintain confidentiality with respect to all information and other material of every kind concerning Artist. Accordingly, I hereby agree that I shall not at any time use or disclose, directly or indirectly, to anyone other than to Artist in connection with the activities under this agreement or in any way relating to Artist, and all such information shall be deemed to be confidential, private, secret and sensitive and shall be kept confidential and secret unless you otherwise advise me in writing. Any and all of the aforesaid confidential information shall remain Artist's, or Artist's designees' sole and exclusive property, free of any claim or interest by me, and shall not be removed, reproduced, summarized, copied, excerpted or utilized in any manner whatsoever without your prior written consent in each instance. To the extent you do not already own such rights, I hereby irrevocably and perpetually assign to you all right, title and interest of any kind or nature, both tangible and intangible, including, without limitation, any copyright, in and to any materials created by you containing or arising out of any of the aforesaid confidential information. I acknowledge that a breach by me of any of the provisions of this paragraph will cause you and/or Artist irreparable harm for which you and Artist will have no adequate remedy at law. Therefore, in addition to any and all other rights or remedies available to you and Artist, you and Artist shall be entitled to injunctive relief and all other remedies provided in such event by law or equity. Such remedies shall include, without limitation, the right to prevent dissemination of any of the aforesaid confidential information prior to its publication.

4. I agree that the privileges granted to me may be revoked at any time. Since it is impractical or impossible to calculate the damages which a breach by me would cause you, I agree that in the event of any breach of any of the foregoing provisions, Paula Abdul, Inc. shall be entitled to liquidated damages in the sum of One Hundred Thousand Dollars (\$100,000).
